<p>1. Recommendation</p> <p>The Hungarian Central Statistical Office and all Other National Authorities should develop a common brand, which would allow better recognition of the value of the data they disseminate and contribute to increasing confidence in official statistics. (Improvement-related: ES CoP, Indicator 1.6)</p>
<p>Current situation:</p> <p>Based on the opinion of the users interviewed during the peer review, out of the institutions of the Official Statistical Service (OSS), HCSO is well-known by the actors of the economy and the society (also influenced by the media appearance larger than usual, linked to the population census), while other members of the OSS are not identified as data-producing organisations. In order for the statistical activity of the other members of the OSS as well as the HCSO to achieve a higher level of cognizance and recognition, the brand of official statistics has to be established and improved.</p>
<p>Improvement sub-action 1.1: Make more information available on HCSO's website about the Official Statistical Service (OSS)</p> <p>Improving the subpage presenting the objectives, activity, operation of OSS as well as the accessibility of official statistical data produced by the OSS.</p>

2. Recommendation
The Hungarian Central Statistical Office should design and implement a capacity-development programme for the Official Statistical Service, particularly for the Other National Authorities developing, producing and disseminating official statistics, to ensure that the Official Statistical Service has the necessary skills to deal with the new data ecosystem's current and future challenges. (Improvement-related: ES CoP, Indicator 7.6 and 3.1)
Current situation:
The accreditation process for the members of the Official Statistical Service, and the right of the HCSO to issue guidelines has provided effective guidance for the Other National Authorities developing, producing and disseminating official statistics to improve and standardise statistical processes and assisted them in advancing beyond operational tasks and focusing on development. There is, however, a growing demand for the HCSO to provide further support after accreditation in developing the statistical capacity of the Official Statistical Service beyond meeting the standards of the National Statistics Code of Practice in view of new data ecosystem requirements.
Improvement sub-action 2.1: Survey the needs of the Official Statistical Service
Carry out a survey of needs by the members of the Official Statistical Service in order to determine the scope of necessary trainings and lack of competences that have to be addressed specifically.

3. Recommendation The relevant government authorities should improve the transparency of the procedure for the appointment of the President of the HCSO, for example by advertising the post. (Compliance-relevant: ES CoP, Indicator 1.8)
Current situation: The Act No. CLV. of 2016 on official statistics introduced detailed rules for the appointment of the President of the HCSO. It further specifies that the President is appointed by the Prime Minister for a period of 7 years that may be renewed twice. However, it does not specifically refer to the start of the process and the advertisement of the vacancy.

4. Recommendation The Hungarian Central Statistical Office should ensure that privileged pre-release access to outside users is justified more clearly, more limited in number and granted in accordance with secure and controlled transmission protocols. (Compliance-relevant: ES CoP, Indicator 6.7)
Current situation: Pre-release access is only granted for first releases, in order to allow ministries, policy departments and the National Bank to prepare their communication related to the first release.

<p>The accesses are highly controlled and limited in order to minimise the risk of leaks. Pre-release access is granted for ministries and the National Bank at 5 p.m. on the day before the release is published. Journalists and news agencies have access at 8 a.m. on the day of release.</p> <p>Among mechanisms ensuring equal access for users, all the first releases and the related datasets are published at 8.30 a.m. on a pre-announced date according to the release calendar.</p> <p>The data are sent to one personal or functional address in each institution via e-mail. No specific transmission channel is used for this.</p>

5. Recommendation

The Hungarian Central Statistical Office should analyse and define options to address issues related to the management of human, financial and IT resources and other ways to ensure increased agility in managing these resources. In particular, the Hungarian Central Statistical Office should examine the potential of a change of its legal status from a head government office to an autonomous public administration body or an autonomous regulatory body (including an analysis of the risks and benefits of all possible options) and discuss with the Cabinet Minister of the Prime Minister the prospect of such a possible change. (Improvement-related: ES CoP, Indicators 3.1 and 10.4)

Current situation:

The HCSO's legal status is that of a head governmental office. Although this setup has advantages, as it confers HCSO full autonomy within its allocated budget, it also generates human, financial resources and procurement limitations that affect the optimal functioning of the HCSO. The centralised management of human resources features fixed categories and salary limits, making it difficult for the HCSO to recruit highly skilled talent and enhance career development prospects and staff promotion pathways. Budgetary planning procedures for yearly financial resource allocation are based on the previous year's budget, which allows the continuation of regular operations but leaves narrow room for the development budget to finance innovation and modernisation. Centralised IT procurement processes increase costs and are not agile enough to maintain the timeliness required to upgrade infrastructure to modernise statistical processes. Such limited flexibility and additional administrative burden put the HCSO in a difficult

<p>position in the context of increasing demands on the HCSO to expand both data production and the role of official statistics as well as be a cornerstone of change in the rapidly developing national data ecosystem.</p>
<p>Improvement sub-action 5.1: Draft an amendment to Act No. CLV. of 2016</p> <p>Draft an amendment to Act No. CLV. of 2016 on official statistics that provides the HCSO with the opportunity to be placed outside the centralised administrative regimes for governmental institutions and which presents the possibilities, options and costs of the change in legal status with a SWOT analysis on advantages and risks to the Government for decision.</p>

<p>6. Recommendation</p> <p>The Hungarian Central Statistical Office and the relevant government authorities should ensure that an appropriate legal framework and other supporting mechanisms are in place to grant the Hungarian Central Statistical Office authority to access and use privately held data. (Improvement-related: ES CoP, Indicator 2.4)</p>
<p>Current situation:</p> <p>Several projects have been developed by the HCSO in partnership with private data holders to use new data sources for the production of official statistics.</p> <p>Despite these positive experiences, legal obstacles remain that prevent a more systematic reuse of privately held data for official statistics that goes beyond the production of experimental statistics. Without an appropriate legal framework that provides the necessary legal security (for instance in terms of data protection and of protection of business secrets), private data holders may hesitate to engage in sustainable partnerships with the HCSO. Similarly, supporting mechanisms (e.g. the development of a methodological framework for the use of such data for official statistics purposes or the development of participatory and public consultation mechanisms leading to a stronger dialogue with and engagement of private data holders, statistical users and citizens) would be needed. Furthermore, the question of compensation for making the data available remains an issue, particularly when the data at stake have a market value and are part of the business model of the company.</p>

7. Recommendation
The Hungarian Central Statistical Office should further develop access to microdata for scientific purposes including by providing researchers with a secure environment for remote access to microdata. (Improvement-related: ES CoP, Indicator 15.4)
Current situation: In HCSO, microdata can be accessed for scientific purposes, applying disclosure control methods, through a number of channels , and among them, remote access. A special kind of remote access service is available from certain access points in Hungary to obtain access to official statistical microdata for scientific purposes. Access to central infrastructure is available from designated access points only.

8. Recommendation

<p>The Hungarian Central Statistical Office should continue improving the service to users, for example, by further modernising the website, enhancing the release calendar, striving to publish increased statistical insights and ensuring the systematic monitoring of user satisfaction. (Improvement-related: ES CoP, Indicators 15.2, 1.4 and 11.3)</p>
<p>Current situation:</p> <p>The design of HCSO's website is responsive, the webpages are respecting the Web Content Accessibility Guidelines recommendations.</p> <p>The release calendar can be accessed from the website; it is made available in November–December for the following calendar year. Some of the ONAs have publication calendars for users, but these are not aligned and cannot be accessed from a common link.</p> <p>The HCSO has elements of open data dissemination, enabling users to re-disseminate its products. The HCSO license model allows for free-of-charge reuse of its data and publications. The HCSO new dissemination database platform, which will gradually replace the current Dissemination database, has a support for SDMX data and metadata downloads.</p> <p>The HCSO has many products aiming to support interpretation of data and help users draw conclusions from statistical information, such as analytical publications. The HCSO also produces visualisation products in order to help understanding statistics. Recently the HCSO launched a subsite for small and medium-sized enterprises, with information customised for this segment.</p> <p>The system of satisfaction measurement applies quantitative and qualitative measures. User satisfaction surveys cover various topics and products. The HCSO also applies indirect methods to find out more about users' activities and needs. The HCSO inserted on its website the heading entitled 'For our users on our users'. Here the HCSO describes its practices, major surveys and the measures taken.</p>
<p>Improvement sub-action 8.1: Develop open data formats, compatible with numerous software</p> <p>Examine open data/linked open data solutions, plan necessary backend and frontend environment.</p>

The Hungarian Central Statistical Office and the institutions producing health statistics should

<p>step up their efforts towards making health statistical data more easily accessible to the users, paying special attention to access to microdata for research purposes and ensuring increased opportunities to interlink different datasets. (Improvement-related: ES CoP, Indicator 15.4)</p>
<p>Current situation:</p> <p>Up to 2018, detailed information on health statistics had been presented in the yearbook on health. After 2018 the HCSO stopped publishing the yearbook, but the health domains of both the Stadat system and the Dissemination database were extended. However, these additions did not fully cover the more detailed information previously available in the yearbook. Data of the European Health Information Survey were published as publications and predefined tables, but the data were not incorporated into the dissemination database. In addition, due to restrictive provisions in the health sector legislation, the access to health data for both statistical and research purposes is limited.</p>
<p>Improvement sub-action 9.1: Improve the dissemination of aggregate data</p> <p>Expand aggregate data content on health available on HCSO's website. Map available micro-datasets, and related statistical disclosure control. Map linking opportunities with other datasets on social statistics, prepare a proposal on the linking of these. Examine linkage opportunities when outside datasets can also be used. Make available linked datasets to users, by defining research objectives for which such datasets are applicable.</p>

<p>Current situation:</p> <p>Custom-designed analyses can be requested from HCSO via the 'Contact us' application or on phone. Internal rules stipulate the process of providing the service and the content of individual contracts to be concluded.</p> <p>The general conditions of requesting such analyses are accessible on the website of HCSO under the heading "Services", but these are not detailed, the products themselves are not published on the HCSO website.</p>
<p>Improvement action 10: Review and enlarge information about custom-designed analyses</p> <p>Reviewing and extending the information available on the website of HCSO on the field of customised analyses</p>
<p>Deadline: Q1 2024</p>
<p>Responsible institution for improvement action 10: Hungarian Central Statistical Office</p>

<p>11. Recommendation</p> <p>The Hungarian Central Statistical Office should reflect on ways to involve the National Statistical Council more pro-actively in forward looking strategic discussions and making it more supportive for the development activities of the Hungarian Central Statistical Office. (Improvement-related: ES CoP, Indicator 1bis.3)</p>
<p>Current situation:</p> <p>The National Statistical Council has several tasks, such as following-up on the implementation of the principles in the ES CoP and National Statistics Code of Practice, advising on the content of the National Statistics Code of Practice, on the annual dissemination programme of the Official Statistical Service as well as advising on the National Statistical Survey Programme from the point of view of user needs and burden on respondents. It acts as an advisory and review body to the President of the HCSO. The Council is active and committed to its work, meets regularly and follows up on statistical work and the annual programmes of statistics. The production of statistics is developing rapidly as data landscape is evolving. Both the members of the National Statistical Council and the HCSO would benefit from adding more future-oriented discussions to the agenda of the Council.</p>
<p>Improvement sub-action 11.1: Introduce strategic issues to the agenda of the National Statistical Council</p> <p>Presentation of the HCSO Strategy, and interim report on the implementation of the strategic goals.</p>

20. Recommendation

The Ministry of Interior together with the Hungarian Central Statistical Office should review the role of the Other National Authorities developing, producing and disseminating European statistics, possibly in the context of the forthcoming accreditation procedure, and assign it to those institutions within the Ministry of Interior that are independently responsible for the production of European statistics. (Improvement-related: ES CoP, Indicator 10.4)

Current situation:

Since its reorganisation in 2022 the Ministry of Interior has been operating with multiple background institutions. The structures whereby statistical activities are performed in the organisation structure of the Ministry of Interior are somewhat complicated. The need for coordinating in a single OSS member a wide range of statistical activities in terms of their nature and scope may itself be indicative of a possible need for clearer segregation of responsibilities.

Improvement action 20: Revise organisational operation

Revising the existing organisation regulation tools may strengthen the regime of responsibility over the official statistical activities and their complete process, help identify decision making powers and quality requirements as well as the way of evaluation of and feedback on their fulfilment. Where justified by a review, even a coordination tool ensuring adequate operation for the attainment of the objectives of the official statistical activities may be developed in order to ensure the application of what is called "process approach".

The Organisational and Operational Regulations may be modified if necessary, to clearly identify and specify the various tasks. The procedural rules of the departments in charge of statistics will be reviewed and, as necessary, supplemented, in order to more markedly provide for statistical activities and responsibilities.

In revising its statistical activities, the Ministry of Interior prepares a guide containing a description of the processes of the various National Statistical Survey Programme data captures and those of receiving data from other organisations, from the generation of data to their disclosure.

Revisions of the cooperation agreements concluded earlier with the HCSO will also be started simultaneously. Aiming at concluding agreements that are transparent for all parties to those agreements and will make communication smoother and quicker. The revision of the cooperation agreements will be aimed at delineating the various specific statistics domains, separating the scopes of responsibilities along with creating a clear-cut cooperation agreement structure.

22. Recommendation

The Hungarian Energy and Public Utility Regulatory Authority should further enhance compliance with the European Statistics Code of Practice by producing regularly quality reports and publishing these on its website, and, in addition, developing a dynamic dissemination database and actively cooperate with the holders of relevant administrative data sources. (Improvement-related: ES CoP, Indicators 15.5 and 15.2)

Current situation:

HEA is currently disseminating only basic quality information as part of the meta data on its website. Detailed quality information is only available at Eurostat website in SIMS format.

HEA is currently disseminating only tabular data in Excel format on its website. The development of a dynamic dissemination database is currently ongoing.

HEA is using multiple administrative data sources mainly from own administrative data collections, but also from other institutions, such as National Tax and Customs Administration. The written agreement with National Tax and Customs Administration is dated back to 2018 and needs revision.

HEA would like to improve statistics on heat pumps. There is a potential administrative data source on heat pumps identified at National Climate Protection Authority, but currently does not have access. The same authority is responsible for ETS (Emissions Trading System) data collection, the access to which would be also useful to check and improve the quality of energy statistics.

Improvement sub-action 22.1: Compile and disseminate quality report on energy statistics on HEA website

HEA will compile and disseminate a quality report on its website based on the results of the latest quality reporting cycle of Eurostat in 2022 including qualitative and quantitative indicators.
