1. General information

Language



The official language in Lithuania is Lithuanian. However, 78.5 % of all Lithuanians are also proficient in one or more foreign languages. The most commonly spoken foreign language in Lithuania is Russian, which is spoken by 63 % of inhabitants. However, a constantly expanding group of Lithuanians (especially young people) speak English, French, German or Spanish.

Administrative settings



The territory of Lithuania is divided into 10 counties (in Lithuanian these are referred to as apskritis), all named after their capitals: Alytaus, Kauno, Klaipėdos, Marijampolės, Panevėžio, Šiaulių, Tauragės, Telšių, Utenos and Vilniaus. The counties are divided into 60 municipalities (in Lithuanian these are referred to as savivaldybė). The largest cities in Lithuania are: Vilnius (541 212 inhabitants), Kaunas (286 754 inhabitants), Klaipėda (147 892 inhabitants), Šiauliai (100 131 inhabitants) and Panevėžys (87 139 inhabitants). Population

Lithuania covers an area of 65 300 square kilometres. At the beginning of 2019, there were 2.79 million inhabitants in Lithuania, 86.8 % among them Lithuanian nationals, 5.6 % Polish, 4.5 % Russian. There are around 58 000 foreigners who live in Lithuania with a residence permit.

Driving licence



Lithuania recognises Ukrainian driving licences, including expired ones, which can be used by Ukrainian citizens while they live in Lithuania and have temporary protection.

Vehicles registered in Ukraine will not have to be re-registered in Lithuania for the period set out in the Government's decision on granting temporary protection.



Ukrainian diaspora

There is a Ukrainian diaspora of 31 000 in Lithuania. Ukrainians are the fourth largest national minority in Lithuania. It is distributed across the country. Most Ukrainians live in Vilnius, Klaipėda, Kaunas, Šiauliai, Visaginas and Jonava.

2. Entry to Lithuania

If you have a biometric passport, you can enter and stay in Lithuania for 90 days within a period of 180 days without a visa.

If you have a biometric passport and your national visas or temporary residence permits expire in Lithuania, then you can immediately start enjoying the 90-day visa-free regime upon the expiry of these documents. In addition, you are allowed to enter Lithuania regardless of whether or not you have biometric a passport.

Healthcare services are available from the day of arrival in Lithuania for those who apply for temporary protection. There are no specific entry requirements regarding vaccinations. However, Lithuania has made it possible for refugees to be vaccinated against COVID-19 under a specific campaign.

3. Temporary protection

- ◆ In Lithuania, temporary protection applies to:
- ◆ Those who left Ukraine on or after 24 February 2022 as a result of Russian military aggression, who fall into one of the following categories:
 1. Citizens of Ukraine who had resided in Ukraine before 24 February 2022;
 2. Stateless persons and third-country nationals who are not nationals of Ukraine and who enjoyed international protection or equivalent national protection in Ukraine before 24 February 2022;
 3. Family members within the meaning of Article 2(4) of Decision (EU) 2022/382 of persons referred to in points 1 and 2 above;
 4. Stateless persons or third-country nationals who are not nationals of Ukraine and who have resided legally continuously in Ukraine before 24 February 2022 on the basis of a valid permanent residence permit in Ukraine, and cannot be safely and permanently returned to their country of origin or to another State which accepts them;
- ◆ Having temporarily left Ukraine not earlier than 24 January 2022 and legally staying in the territory of the EU or in another third country when they fulfil the conditions set out in points 1 to 4 above and entered the Republic of Lithuania before 1 May 2022.

Where can you register for temporary protection in Lithuania?

You can register for temporary protection in the nearest territorial branch of the Migration Department, called the Migracijos departamentas, during working hours. The list of offices available here: https://lrv.lt/uploads/main/documents/files/info%20ua_new_ENG.pdf

It is also possible to register in a 24-hour Registration Centre which operate as one-stop service points for persons with accommodation needs. Those who need accommodation should choose this option for registration. What documents do you need for registration?

Any relevant documents such as passport, birth certificate, marriage certificate, other personal documents and any other identity documents, such as identity card, driving licence, residence permit, etc.

What is the procedure to access temporary protection in Lithuania?

Applicants should present themselves at either one of the registration centres or the Migration Department territorial branch and submit documents. Before the registration, applicants can fill out the electronic application for the residence permit provided by the relevant authorities. Guidance on how to fill out the form is available here:

After registration and while waiting for a residence permit issued on the ground of temporary protection, all Ukrainians and their family members, as well as third country nationals eligible for temporary protection, are issued with a foreigner's registration certificate. The Migration Department under the Ministry of the Interior is responsible for issuing certificates and temporary residence permits.



Which documents will you receive as a beneficiary of temporary protection?

After the registration refugees are entitled to:

- ◆ obtain a temporary residence permit in Lithuania valid for 1 year;
- ◆ a national visa valid for 1 year.

National visas will not be issued to citizens of Ukraine who are not holders of valid foreign passports, but applications for temporary residence permits for humanitarian reasons will be accepted.

No state fee will be charged for examining and deciding on applications for national visas or temporary residence permits.

Duration of temporary protection

Temporary protection is valid for 1 year, as per Council Implementing Decision (EU) 2022/382 of 4 March 2022. After 4 March 2023, if necessary, the EU may extend the decision to grant protection by six months at a time, up to a maximum of three years in total. If the situation changes and the EU considers that it would be possible to return to Ukraine safely and permanently, the Council could decide to end the protection in a shorter period.

Accommodation



Accommodation for Ukrainians fleeing the war is managed by the Ministry of Social Security and Labour, Socialinės apsaugos ir darbo ministerija, in coordination with the municipalities. Information is available here: <https://socmin.lrv.lt/en/>

There is also a civil initiative ‘Stronger Together’ where the housing is offered by Lithuanian citizens who volunteer to host Ukrainians fleeing from the war.

Initial reception



Refugees fleeing Ukraine are entitled to be accommodated for up to 72 hours in one of the temporary registration centres established across the country: <https://migracija.lrv.lt/ltaudinga-informacija/ukraina-ukrayina-ukraina-ukraine/information-for-ukrainian-citizens-1/migration-services>

The registration centres provide the following services:

- ◆ accommodation up to 72 hours;
- ◆ registration (in the national database Migris) and start of the migration procedures;
- ◆ medical services;
- ◆ food packages;
- ◆ information on available long term accommodation, employment possibilities



Long-term accommodation

Following the initial accommodation at the temporary registration centre, refugees are channelled through the #StrongerTogether Platform, which provides free of charge accommodation up to 3 months. The platform is available here: <https://stipruskartu.lt/ua/>

If the platform does not have the necessary accommodation option, the municipality will get involved and coordinate the accommodation. The municipality may offer apartments, care homes, dormitories, school premises, and orphanages for Ukrainians in need.

Ukrainian citizens with the right to a visa-free stay or those that hold a valid Schengen visa, as well as Ukrainian citizens who have obtained national visas on humanitarian grounds or a temporary residence permit in Lithuania, will have the right to work or carry out self-employed activities. These citizens are exempt from the obligation to obtain a work permit. Ukrainian citizens who have applied for international protection in the Republic of Lithuania will also have the right to work.



Registration and consultation can be carried out at any department of the Employment Service or by telephone. More information can be found here: <https://uzt.lt/en/>

Upon registration with the Employment Service, an officer will be appointed to provide full information on the services provided by the Employment Service. The consultation is available in English and Russian.

Those who want to practice a regulated profession should obtain the recognition of professional qualification. To that end, the person should apply to the competent authority for the recognition of professional qualification. The institution will apply for recommendation in connection with the assessment of foreign qualification to the Centre for Quality Assessment in Higher Education, called the Studijų Kokybės Vertinimo Centras (SKVC): <https://www.skvc.lt/default/en/>



Mandatory veterinarian check-up for pets

The State Food and Veterinary Service has facilitated the entry of pets. Ukrainians whose pets are properly marked, vaccinated, have a valid animal passport, and meet all the requirements for the entry of pets into the EU will follow the usual procedure for crossing the border. Animals coming from Ukraine that are not microchipped or have not been vaccinated against rabies will be microchipped and vaccinated, and therefore subjected to simpler quarantine conditions. - ◆ Childcare/nursery

Information on the enrolment of Ukrainian children in educational institutions is available from the municipal education departments where coordinators have been appointed. They provide all the necessary information on school or kindergarten admission.

Kindergaten capacities are almost exhausted. To accommodate more Ukrainian children in Lithuanian kindergartens, hygiene norms are being changed to allow kindergartens to form larger groups of children. This is a temporary solution, which will be in place for a year.

- ◆ Primary and secondary school



You can enrol your child in school by applying to the admissions department of your local municipality. Children should be enrolled without delay with no need to wait until the next school year.

- ◆ University

Students whose studies have been interrupted in Ukraine can continue their studies in Lithuania in English and Russian. Study programmes and higher education institutions are available here: <https://studyin.lt/ua/>

The ministry of education, science, and sport, Švietimømokslo ir sporto ministerija, will provide students that continue their studies in Lithuanian higher education with monthly scholarships that will aid with covering basic necessities.
