# 1. General information



## Language

The official language is Romanian. It is spoken as a first language by approximately 90 % of the population. There are approximately 50 000 native speakers of Ukrainian (concentrated in the regions near the border with Ukraine). English is taught as the first foreign language at most schools.



## Regions/administrative settings

Romania is divided into 41 counties (județe) and the municipality of Bucharest (the capital of Romania). Each county is subdivided further into cities and communes. The municipality of Bucharest is further divided into six sectors.

Bucharest is the nations' capital and largest city. Other major cities include Cluj-Napoca, Timișoara, Iași, Constanța, Craiova, Brașov, Galați, Ploiești, Oradea, Brăila, Arad, Sibiu. Romania has been a Member State of the European Union since 2007.



## Population

The estimated population on 1 January 2021 was 19.2 million. Ukrainians are the third-largest ethnic minority in Romania, with a population of 51 700 according to the 2011 census. Ukrainians mainly live in the counties along the border with Ukraine.

## Driving licence



Driving licences issued in Ukraine and that are still valid, can be used in Romania for driving all categories of vehicles covered by the driving licence. Expired, lost or stolen driving licenses issued in Ukraine cannot be exchanged for Romanian ones. ## Ukrainian diaspora

Ukrainians are the third largest ethnic minority in Romania, with a population of 51 700 according to the 2011 census. Ukrainians mainly live in the countries along the border with Ukraine. The Union of Ukrainians of Romania and the National Forum of Ukrainians of Romania are the two organisations of the Ukrainian ethnic minority in Romania. At the end of 2021, more than 2 200 Ukrainian citizens were in possession of a residence permit in Romania. Maramureş, Bucharest and Suceava are the top 3 locations where Ukrainians in Romania live.

## 2. Entry to Romania

On arrival to Romania via the border crossing points, a border check will be carried out. Ukrainian citizens are allowed to enter Romania regardless of the type of travel / identity document they present at border check (biometric passport, simple passport, identity card or other documents). Romania offers protection to anyone fleeing the war in Ukraine, regardless of nationality. Nevertheless, you can be additionally checked at the border crossing point if you do not have any documents.

There is no requirement to present a certificate of vaccination or valid PCR test to enter Romania from Ukraine. You are not required to quarantine either if you arrived by land to Romania from Ukraine.

After crossing the border, go to the information point if you need assistance. You will receive information about your stay in Romania, accommodation, a hot meal, and medical assistance.

# 3. Temporary protection

All important information on temporary protection in Romania is available on the website of the General Inspectorate for Immigration (<https://igi.mai.gov.ro/ucraina/>, available in Ukrainian, Romanian and English) and the governmental platform <https://protectieucraina.gov.ro/1/aplica-pentru-protectie-temporara/>.

The following categories of persons can enjoy temporary protection in Romania:

- a. **Ukrainian citizens** who lived in Ukraine before 24 February 2022, regardless of when they left Ukraine, as well as **their family members**;
- b. **non-Ukrainian third country nationals or stateless persons** who benefited from **international protection or equivalent national protection in Ukraine** before 24 February 2022, as well as **their family members**;
- c. **non-Ukrainian third-country nationals or stateless persons** who prove that they have legal residence in Ukraine on the basis of a **valid permanent residence permit** issued in accordance with Ukrainian law, and **who cannot return in safe and durable conditions** to their country or region of origin.

**Family members** are, irrespective of their nationality:

- ◆ husband/wife (legally married);
- ◆ minor and unmarried children, born in or out of wedlock or adopted;
- ◆ other close relatives who lived together, as part of the family unit, when the events that led to the massive influx of displaced persons occurred and who were at that time totally or mainly dependent on the person benefiting of temporary protection.

## Where can you register for temporary protection in Romania?

You can register for temporary protection at any of the 46 immigration structures of the General Inspectorate for Immigration (*Inspectoratul General pentru Imigrări*). The list is available for download at <https://protectieucraina.gov.ro/1/aplica-pentru-protectie-temporara/>, or you can consult the map at <https://igi.mai.gov.ro/contact/>.





If you are a non-Ukrainian third-country national or stateless person with a valid permanent residence permit in Ukraine, and you cannot return in safe and durable conditions to your country or region of origin, you can register only at one of 42 Directorate/Service/Office for Immigration from the list above. What documents do you need for registration?

Depending on your situation, the following documents may be required to register for temporary protection:

- ◆ identity documents (identity card, driving license, travel document or any other authentic document with a photograph);
- ◆ documents proving the status of the person in Ukraine (e.g. permanent residence permit, document issued to beneficiaries of international protection);
- ◆ documents proving the family ties (e.g. family card, birth/marriage certificate).

## What is the procedure to access temporary protection in Romania?

Registration as a beneficiary of temporary protection in Romania is a simple procedure carried out by the General Inspectorate for Immigration.

At the time of presenting yourself to the authorities, you will go through the following steps:

- ◆ you sign a consent form regarding the processing of your personal data;
- ◆ the personal documents you present are photocopied;
- ◆ your personal documents are verified;
- ◆ you are photographed;
- ◆ the following personal data are recorded: surname and first name, date of birth, citizenship, sex, identity, civil status, family situation, family ties, address in Romania (if known);
- ◆ you receive a residence permit in Romania with a personal numerical code (*cod numeric personal (CNP)*)

## What documents do you receive as a beneficiary of temporary protection?

The General Inspectorate for Immigration issues to the beneficiaries of temporary protection a residence permit on the territory of Romania and assigns them a personal identification number (*cod numeric personal*). The residence permit and the personal numerical code are used in the



interaction with the Romanian authorities to enjoy the specific rights attached to temporary protection.

## Duration of the temporary protection

Temporary protection lasts until 4 March 2023 and can be renewed for two consecutive periods of 6 months each, meaning until 4 March 2024. This period may be extended for another year depending on the situation in Ukraine.

Temporary protection may be terminated before the above time limits, under conditions established by law, when this is decided by a decision of the Council of the European Union.

## Your rights as a beneficiary of temporary protection in Romania

Your rights as a beneficiary of temporary protection include the following:

- ◆ Residence in Romania
- ◆ Information about the contents of temporary protection
- ◆ Access to the labour market
- ◆ Necessary assistance for subsistence, if you do not have the necessary material means
- ◆ Free primary health care and appropriate treatment, emergency hospital care, medical assistance and free treatment in case of acute or chronic illnesses that put your life in imminent danger
- ◆ Adequate medical care if you have special needs
- ◆ Access to education
- ◆ Family reunification

## More information about these rights



Various central and local authorities are responsible for ensuring that beneficiaries of temporary protection can access their rights. International organisations and specialised non-government organisations also provide additional support and services, and can help you interact with the authorities. In some large cities, the local authorities together with specialised non-governmental organisations have opened integrated support centres for Ukraine.

### Initial reception



If you do not have anywhere to stay after crossing the border into Romania from Ukraine or Moldova, go to the information point at the border crossing point. Families with children can benefit from immediate support services at one of the seven Blue Dot child and family support centres.

The staff present in these information points will help you find accommodation in locations offered by local authorities, civil society, economic entities, or private persons.

### Long-term accommodation



Currently, there are no provisions for long-term accommodation. If you need accommodation, please submit a request on the platform 'A Roof / Un Acoperiş' at <https://unacoperis.ro/uk> (available in Ukrainian, Russian, English and Romanian). The platform is managed by the Government together with the civil society. It centralises public and private offers and requests for accommodation for those fleeing Ukraine. Locations are verified in order to reduce risks and ensure safety.

The Romanian government is supporting the private persons who are hosting persons displaced from Ukraine. If you are hosted by a private person, your host may claim the reimbursement of expenses for food and accommodation. Your host needs to contact the Social Assistance Directorate of the City Hall where you live.



The Romanian government is working on setting up provisions for long-term accommodation.

## Access to labour market

Beneficiaries of temporary protection have the right to access the labour market without a work permit. You have the right to be employed by natural or legal persons or to carry out independent activities in compliance with the rules applicable to your profession. You have also the right to engage in activities such as educational opportunities for adults, vocational training and practical workplace experience, in accordance with the law.

If you want to work in a field for which you already have a professional qualification or work experience, but you do not have the necessary documents with you (diplomas, certificates), you may be employed on the basis of a declaration on your own responsibility (available in Ukrainian on the website of the National Employment Agency at [https://www.anofm.ro/upload2/ANOFM/19994/ANEXA\\_-\\_declaratie\\_UA.pdf](https://www.anofm.ro/upload2/ANOFM/19994/ANEXA_-_declaratie_UA.pdf)). This option is only valid for a period of 12 months, with the possibility of further extension by periods of 6 months, for a maximum of one year. This does not apply if you want to practice in Romania the professions of doctor, dentist, pharmacist, general nurse, midwife, veterinarian, architect, or any other regulated professions.

You can also benefit from measures to stimulate employment, as well as from protection within the unemployment insurance system at the same conditions as Romanian citizens. To this end, you need to register with the local agencies for employment (for contact details see <https://www.anofm.ro/index.html?agentie=&categ=7&subcateg=2>.)

## Social welfare and means of subsistence

Persons who do not have adequate material means can request assistance for subsistence. You can receive food, clothing, and hygienic products.

You can also submit a request on the platform 'Emergency support / Sprijin de urgență' at <https://sprijindeurgenta.ro/>.

If you are a vulnerable person, contact the General Directorate of Social Assistance and Child Protection or the Social Assistance Directorate / Social Assistance Service from the county or sector in Bucharest where you live. ## Public health

### Medical care/medical prescription

Beneficiaries of temporary protection have the right to receive:

- ◆ free primary care and appropriate treatment,
- ◆ emergency hospital care,
- ◆ free medical care and treatment in cases of acute or chronic life-threatening illness.

Persons with special needs have the right to receive adequate medical assistance.

Medical services in specialised outpatient healthcare are provided without the need to present a referral from the doctor.

You can register with a family doctor of your choice.

Within the national health programmes managed by the National Health





Insurance House, you can benefit from medicines, sanitary materials, medical devices and medical services without paying the social health insurance contribution, the personal contribution for the medicines granted in the outpatient treatment and being exempted from co-payment.

### Psychosocial support

### Disabilities

If you are a vulnerable person or a person with disabilities and need assistance, contact the General Directorate of Social Assistance and Child Protection or the Social Assistance Directorate / Social Assistance Service at the county or sector in Bucharest where you live. An interactive map with contact details of all Directorates is available at <http://copii.gov.ro/1/harta-contacte-dgaspc-uri/> and at the border crossing points.

Persons with disabilities can benefit, upon request, from the social protection services: sheltered housing, independent living training centres, rehabilitation, care and assistance centres, crisis centres.

Elderly people with reduced mobility or in a situation of dependency can benefit, upon request, from social services.



### COVID-19

There is no requirement to present a certificate of vaccination or valid PCR test to enter Romania from Ukraine. You are not required to quarantine



quarantine either if you arrived by land in Romania from Ukraine.

Voluntary vaccination against COVID-19 is available free of charge. If you have tested positive for COVID-19, you will receive all the necessary care free-of-charge.

### **Mandatory veterinary check-up for pets**



Romania introduced a temporary derogation from rules for the entry of pets from Ukraine. If your animal is not vaccinated against rabies or if the vaccination is no longer valid, you must fill in the [Pet Location Form](#), and you will be able to complete all the formalities and procedures after entering Romania. However, before proceeding to another EU country, you must complete all the formalities and obtain the necessary documents for your pet.

### **Access to education**



Children have the right to education in Romanian schools under the same conditions as Romanian students. They have the right to free accommodation in boarding schools, food allowance, supplies, clothing, footwear and textbooks.

Children can go to the kindergartens and schools of the city where they live. You can enrol your child in kindergarten or school by applying to the nearest school inspectorate. The registration form is available in Ukrainian [here](#).

## Regional Integration Centres
