

## 1. General information



### Language

Danish is the official language of Denmark. Danish is spoken by about 6 million people, mainly in Denmark but also in Greenland and the Faroe Islands. Greenlandic is the official language in Greenland and Faroese is the official language in the Faroe Islands.



### **Administrative settings**

Denmark is divided into 5 administrative regions.

## 2. Entry to Denmark

Provided that the basic conditions for entry are met, Ukrainian nationals (including children under 18 years of age) who have a biometric passport or a residence permit for the Schengen area can enter Denmark with no need to obtain a visa in advance. If you do not have a biometric passport, you must have a short stay visa in order to enter Denmark.



Applications for a visa for Denmark are processed by the Danish diplomatic missions. In some cases, applications are forwarded to the Danish Immigration Service for assessment and decision. To receive a visa, you must normally meet the following basic conditions:

- Your passport or travel document must be valid for 3 months past the visa expiration date.
- Your passport or travel document must have been issued within the past 10 years.
- ◆ You must have the necessary funds to pay for your stay and return trip. The Danish diplomatic mission (or the Danish Immigration Service, if the case is forwarded to them) will determine the amount that is deemed necessary, depending on the length of your stay and place of accommodation (hotel or staying with friends/family). As a general rule, you must have at your disposal approximately 350 DKK per day. If you are staying at a hotel, the necessary amount is approximately 500 DKK per day.







- You must hold a travel insurance policy to cover possible expenses in connection with a return for health reasons or death, indispensable medical treatment or acute hospitalisation during your stay. The insurance policy must cover all Schengen countries, and the minimum coverage is 30 000 EUR. The insurance policy must be valid for the same period as the visa. The validity of the visa may be shortened if the insurance policy does not cover the entire period.
- You must not be registered as a persona non grata in the Schengen Information System (SIS II).
- You must not have been deported from Denmark and given an entry ban.
- You must not be listed on UN or EU sanction lists.

These conditions apply at the time your visa is issued, as well as when you enter and stay in the Schengen area.

If the Danish diplomatic mission or the Danish Immigration Service suspect that you intend to seek permanent or long-term residency in Denmark, or that you may pose threat to national security or public safety, your visa application will be rejected.

## 3. Temporary protection

Under certain conditions, people from Ukraine can be granted a temporary residence permit in Denmark under the law on temporary residence permits for displaced persons from Ukraine (Special Act). To this end, you must meet the requirements below.

- You are a Ukrainian national or you were recognised as refugee in Ukraine as of 24 February 2022.
- You left Ukraine on or after 1 February 2022, unless you were residing or had another residence permit in Denmark as of 24 February 2022.

You are a close family member of a person in Denmark who was granted a residence permit under the Special Act (section 1 or 2(1)(1)).

## Where can you apply for a temporary residence permit in Denmark?

The Danish Immigration Service is the responsible authority to receive and reply to the application. The application for a temporary residence permit is launched online through a dedicated electronic application form and is also available in PDF and Word.

### What documents do you need for your application?

Depending on your situation, the following documents may be required:

- passport or other identity document (both original and copies);
- if relevant, passport or other identity documentation of any children included in your application;
- documentation proving your refugee status in Ukraine (only if you are not a Ukrainian citizen);
- documentation proving family ties, for example marriage or birth certificates:
- employment contract (only if you have been offered a job in Denmark).

## What is the procedure to obtain a temporary residence permit in Denmark?

You can fill in an electronic application form or print it out and submit a physical application.

After completing the application, you need to book an appointment at the Danish Immigration Service's Citizen Service to have your biometric data recorded and your identity checked. This applies unless your biometric data were recorded upon arrival in Denmark.

## Which documents do you receive as a holder of a temporary residence permit?

You will be granted a residence permit for temporary residence in Denmark.

#### **Duration of the temporary residence permit**

The temporary residence permit is valid until 17 March 2024.

#### **Accommodation**



While your application for a residence permit under the Special Act is being processed, you can be accommodated in a reception or accommodation centre. You can also find your own accommodation, e.g. with family or friends. If you are granted a residence permit under the Special Act, the Danish Immigration Service will decide which municipality you will live in. The municipality will be responsible for your integration, including finding a place for you to live, supporting in finding employment and the payment of benefits. #### Access to labour market



If you have been granted a temporary residence permit, you have the right to work in Denmark. The temporary residence permit gives you access to the labour market system for both dependent and independent economic activity.

You may also be entitled to work once you have filed an application for a residence permit under the Special Act and have had your biometric data recorded.

#### **Writing your CV**

When applying for a job, you should include a curriculum vitae (CV).



A CV is a brief document with your contact details and an overview of your skills, spoken languages, job experience and educational background.

Most employers accept CVs written in English. Your local municipality can help you create a CV.

#### Sending your application

Your application should include a short personal statement (max. 1 page) about your motivations for applying for the specific job. Applications are usually submitted electronically. You can also print it out and hand in a physical copy to the employer.



#### Tax card

A tax card is a digital document informing your employer of how much you should pay for tax.

If you work in Denmark you need to have a tax card, otherwise you will pay 55 % tax on your salary.

Your employer can help you get a tax card. You can obtain a tax card in two ways:

- by using the online self-service system (log on to <u>www.skat.dk</u>);
- by using an online form.

#### Bank account

All citizens in Denmark need to have a *NemKonto*. This is a normal bank account to where you can receive get any payments from the public authorities, e.g. tax returns. You can register a Danish or Ukrainian bank account as your *NemKonto*.

#### Salary and employment conditions

It is important that you learn about the normal pay and working conditions for the job that you have been offered.

You can contact a trade union to receive advice about pay and conditions that have been agreed between social partners even though they are not legal requirements in Denmark.

#### Social welfare

If you are staying legally in Denmark, you are entitled to aid and support under the Danish Act on Social Services. This includes for instance aids and appliances for persons with disabilities and support for vulnerable children. Decisions regarding aid and support under the Act on Social Services are made by the municipality.

Once you obtain your residence permit, you will gain immediate access to the labour market on par with Danes and other EU citizens.

Depending on your personal and financial circumstances, you may also receive help through the cash benefits system (the general minimum income scheme in Denmark) and other benefits. The type and extent of supplementary benefits that you may receive depend on factors such as being a single parent / only provider for your family, number of dependent children, type of housing and cost of rent.

#### Means of subsistence in the reception system

After you have applied for a residence permit under the Special Act and until a residence permit has been issued, you may choose to stay at one of the Danish Immigration Service's reception and accommodation centres. In this case, the Danish Immigration Service will cover your expenses for subsistence and necessary health services.

While the application for a residence permit under the Special Act is being processed, children will be offered education at, or in affiliation with, the centre at which they are staying. The content and scope of provided education will correspond to the education offered to bilingual pupils attending Danish primary and lower-secondary school.

#### **Public health**

#### Medical care/medical prescription

After you have applied for a residence permit under the Special Act, you have access to several healthcare services. Access to health care depends on the status of your application and your place of residence.









#### **Ukrainians with a residence permit in Denmark**

Displaced persons from Ukraine and arriving to Denmark can receive necessary health services by the Danish Health Authority.

After obtaining a residence permit under the Special Act and receiving a Danish social security number (CPR number), people from Ukraine are entitled to all benefits under the Danish Health Care Act. It is possible to issue the yellow health card once the person has received the CPR number.

The right to health benefits is granted on an equal footing with other residents of Denmark. #### **Ukrainians without a residence permit in Denmark**

The Capital Region of Denmark hosts a medical clinic to help displaced persons from Ukraine to receive medical care. This clinic is for displaced persons from Ukraine who have applied for a residence permit in Denmark under the Special Act and who are awaiting the processing of their applications.

You can use the clinic both if you are staying in a private home or in a municipal accommodation. To access the clinic's service you need to show the receipt that you received when you applied for the residence permit or when you had your biometric data recorded.

If you are staying at a reception or accommodation centre operated by the Danish Immigration Service, you have access to necessary healthcare at the health clinic of the centre.

#### Right to emergency and continued hospital treatment

Persons who have not applied for a residence permit under the Special Act are entitled to emergency and continued hospital treatment. The treatment covers hospital treatment in case of accidents, sudden onset of illness, onset or sudden worsening of chronic illness, etc. The regional hospitals can offer assessment and treatment that exceeds the urgent





need for treatment if the hospital assesses that, under the specific circumstances, it is unreasonable to refer the patient to treatment in their home country.

Persons who have applied for a residence permit under the Special Act, whose expenses for subsistence and necessary healthcare services are covered by the Danish Immigration Service, will also have access to necessary healthcare.

#### **Right to necessary treatment**

If you have applied for a residence permit under the Special Act and your accommodation is not provided by the Danish Immigration Service, you are entitled to necessary benefits under the Health Act.

If you live in an accommodation provided by the Danish Immigration Service, you have access to necessary healthcare at the health clinic of the reception centre.

Treatment is considered necessary if it is urgent and/or pain relieving.



Treatment is considered urgent if delaying it could lead to life-threatening injuries, degeneration or serious worsening of your condition, or to your condition becoming chronic.

#### **Entitlement to all benefits under the Health Act**

Displaced persons from Ukraine who have been granted a temporary residence permit under the Special Act are entitled to all the benefits of the Health Act if they have a CPR number and the yellow health card.

Children are entitled to the same level of health care as Danish citizens, regardless of their residence status.

#### **Psychosocial support**

The Danish Refugee Council offers Ukrainians in Denmark the possibility to have a telephone conversation with a Ukrainian-speaking psychosocial professional. The focus is on personal reactions, and especially how to support children in the special situation they are in.



It is possible to arrange from 1 to 3 sessions on the phone or to meet face to face. This depends on needs, geography, etc.

#### **Psychiatric care**

If you or someone you know need urgent psychiatric help, you can contact the mental acute psychiatric admission centres in your region.

#### **Disabilities**

The Danish Immigration Service can offer accommodation suitable for displaced persons from Ukraine without a residence permit who are seriously ill or in need of special care.

#### COVID-19

Currently there are no COVID-19 related restrictions to enter Denmark.

However, it is still important to follow the Danish Health Authority's 6 steps for infection prevention. Please follow them at home, in public spaces, in school and in the workplace. Please note that private businesses and private cultural institutions can still require to show the EU COVID pass or to use of a face mask/shield.

You can receive free vaccination against measles, polio and diphtheria.

#### Information leaflets on health-related subjects

**Health system:** when you have a residence permit and a place of residence in Denmark, you are entitled to free treatment in most of the healthcare system. Read more about how you are examined and treated in the leaflet 'You and your health' (English version, Ukrainian version, Russian version).



**Pregnancy and birth in Denmark:** this pamphlet is made for pregnant women who have recently moved to Denmark. It describes the health services that are available for pregnant women in Denmark and provides important advice on pregnancy and birth (English version, Ukrainian version, Russian version).

**The health of young children:** this pamphlet is for those who have recently moved to Denmark and have children under 6. It provides information on the healthcare services that are relevant to you and important advice for children's health (English version, Ukrainian version, Russian version).





Following the Russian invasion of Ukraine, the EU and Denmark have adopted a special derogation from Regulation (EU) No 576/2013. As a result, people travelling with their pets from Ukraine can import them into the EU/Denmark, even if the animals do not meet all the requirements. If you arrive to Denmark from Ukraine with your pet(s), follow the steps below:







- isolate your pets from contact with other animals and people;

#### Access to education

#### Day care, primary and lower-secondary education

Ukrainian parents with legal residence status in Denmark have the right to access day care services in Denmark for their children aged 0-5 years. Under the Day Care Act, the municipality of residence must offer the child a place in an age-appropriate day care centre, at the latest 3 months after the relevant application has been filed.

In Denmark, compulsory education is for 10 years. It is provided to children between 6 and 17 years of age. Children from Ukraine aged 6 to 17, who have either obtained legal residence or are deemed by the Danish authorities to aim to take legal residence in Denmark (for a period of six months or more) are subject to compulsory primary and lower secondary education.



The municipalities are responsible for ensuring that all children in mandatory school age either attend a regular primary and lower-secondary school (*folkeskole*) or receive other education of the same quality as education given in the Danish public school system.

New legislation has increased flexibility in the day care and primary and lower-secondary school area regarding displaced persons from Ukraine with a residence permit under the Special Act. Among other things, municipalities in Denmark have more flexibility when it comes to establish special offers for displaced children and adolescents from Ukraine.



#### **Upper-secondary education**

Ukrainian adolescents who have obtained legal residency in Denmark and have completed primary and lower-secondary education can apply for enrolment in an upper-secondary education programme.

If the pupil has completed schooling that corresponds to the Danish primary and lower-secondary school and has the competences necessary for the eventual completion of the upper-secondary education programme, then they have the legal right to enrolment.

As provided in the law passed on 19 May 2022, upper-secondary education institutions are authorised to use Ukrainian or English as the main language of instruction and to use long-distance teaching for adolescents with a residence permit under the Special Act.

#### **Higher education**

If you have obtained a temporary residence permit under the Special Act, you are exempt from paying tuition fees for full-time higher education.

#### State educational grant and loan scheme (SU)

Ukrainian citizens who have obtained a temporary residence permit under the Special Act may be granted equal status with Danish citizens in relation to the right to receive the state education grant (SU). SU is a monthly grant that students receive from the Danish state to cover the cost of living. Only students who have been admitted to a study programme in Denmark can receive it. #### Assessment and recognition of qualifications from Ukraine

The Danish Agency for Higher Education and Science can make an assessment of Ukrainian educational qualifications.

if you request an assessment of your qualifications, you will receive a letter explaining to what your Ukrainian qualifications correspond in Denmark (educational level, and in some cases, field of education).







The assessment can be helpful when looking for a job or when applying for further education in Denmark. ## 4. International protection



Any foreign national in Denmark can submit an application for asylum. You can apply for asylum regardless of whether you entered Denmark illegally or have a residence permit or visa. It is possible to apply for asylum in Denmark only if you are in Denmark. You can also apply for asylum in Denmark at the Danish border. It is not possible to apply for asylum by enquiring at a Danish representation (embassy or Consulate General) outside Denmark. If you do not have a residence permit, you can apply for asylum by showing up in person at a police station in Denmark or at the police in Centre Sandholm. If you already have a residence permit (on other grounds than asylum) in Denmark, you can apply for asylum by showing up in person at the police in the district where you live.

The Danish authorities have presently suspended processing applications for asylum from Ukrainian citizens pending updated information on the current situation in Ukraine.
