

**COMMISSION REGULATION (EC) No 2210/2002
of 12 December 2002**

**amending the rates of the refunds applicable to certain milk products exported in the form of
goods not covered by Annex I to the Treaty**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1255/1999 of 17 May 1999 on the common organisation of the markets in the milk and milk products sector ⁽¹⁾, as last amended by Regulation (EC) No 509/2002 ⁽²⁾, and in particular Article 31(3) thereof,

Whereas:

- (1) The rates of the refunds applicable from 1 December 2002 to the products listed in the Annex, exported in the form of goods not covered by Annex I to the Treaty, were fixed by Commission Regulation (EC) No 2135/2002 ⁽³⁾, as amended by Regulation (EC) No 2171/2002 ⁽⁴⁾.

- (2) It follows from applying the rules and criteria contained in Regulation (EC) No 2135/2002 to the information at present available to the Commission that the export refunds at present applicable should be altered as shown in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The rates of refund fixed by Regulation (EC) No 2135/2002 are hereby altered as shown in the Annex hereto.

Article 2

This Regulation shall enter into force on 13 December 2002.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
