The general directions of the formed plan are: A) The easier and direct access of citizens to the state laws. B) The service of editorial needs of the public sector. C) The technological modernisation aiming at the service of citizens. The national printing house of Greece, based on the above mentioned, is working a plan in development which concerns the modernisation of the building in which is accomodated. Part of the plan is also the further use of new technologies of the information technology while we steadily follow the technological achievements and developments concerning printing facilities.
