		The Public Enterprise Official Gazette of the Republic of Macedonia, is a public company established by the Government. All the property of the company is in states hands, which means that R.Macedonia is the owner of this company.

It is important to be stressed that in The Official Gazette of
	medium term (3-5 years):	the Republic of Macedonia legislation acts are publishing free of charge (Assembly acts, Governmental acts, ministry acts and the other) according to the Law on publishing the laws and other regulations and acts in the Official Gazette of the Republic of Macedonia (art. 10 par. 1). Only subscribe for this kind of acts is paid.
		The majority part of income originates from the subscriptions to the Official Gazette of the Republic of Macedonia, the legal registry, as well as, the payments for

publications (courts announcements, notary announcements, public procurement tenders, etc), according to the valid price list stipulated by the Managing Board decisions, based on Governmental approval, and for the sale of books according to the price stipulated by the Managing Board decisions.

The laws, other regulations and acts are publishing in a paper form since 1945, and in a electronic form since 2003. PE Official Gazette of the Republic of Macedonia has an extensive archive of almost 7000 titles from all the regulations that are in force, dating back from 1945 to date.

At the moment, we are preparing to apply XML standars in our work.

We see a great opportunity in exploring the electronic information published in OJ. We are thinking over selected marketing on information, which are interested for extended circle of end-users.

Other plans or 6.2 discussed issues:

Changes on major items from the questions above are being expected in year 2005. Any intervention in our founding Act could change many things. The company was established in accordance with the Law on publishing the laws and other regulations and acts in the Official Gazette of the Republic of Macedonia (OG RM, No. 56/99, 43/02). However all decisions on potential changes are dependent on governmental decisions. Te company could initiate certain changes.

Changes on major items of our founding Act are expected in the end of the year 2005, so it could change many things in the organization and functioning of the company.
