

## **Exchange of personal data for the purposes of administrative cooperation purposes via the IMI system**

Under EU single market laws, people and businesses have certain rights to move around the European Economic Area for work, study, trade, etc. If a EU/EEA member state authority is involved in implementing laws related to one of these areas, they may need to exchange information with similar bodies in other countries via the Internal Market Information System (IMI).
