Your Office or Organization is kindly requested to complete Section VII by indicating the implementation status of WIPO Standards listed in the template and providing any relevant details regarding their implementation.

In preparing the ATR, any information on imminent or foreseeable changes in working methods in your Office or Organization would be appreciated, particularly in connection with any automation plans concerning patents and utility models.
