Course Name:

Shipping Explained

Course Location:

UK port – TBC.

Purpose of the Course:

An understanding of international shipping is a vital skill for global book production and distribution professionals. Getting books printed is only half of the job – once they are made you need to deliver the books to your customers safely and cost effectively.

Benefits of attending:

Taught by industry experts and including a port tour, this course will show delegates up-close the sheer scale of the shipping industry, providing an understanding of how it works, its terminology, the documentation required and how to manage the process effectively. Delegates will see the supply chain in action and gain an understanding of the relationships of those in it, learn to speak the language of the shipping industry, and find out what to ask in order to make sure their books are shipped using the most appropriate method.

As the number of people allowed on to the port is severely restricted, the number of delegates for this course is limited to 4 only.

Course Level:

This course is aimed at those who are or would like to be in book production, and those within publishing for whom shipping is a key part of their job role. It is aimed at those with little or no prior knowledge of shipping.

Course Content:

This course has a practical emphasis and will ensure that all theoretical elements are accompanied by a practical application. We take a thorough look at sea, air and road freight, assessing their pros and cons and their most appropriate usage.

The topics covered will include:

• **Supply Chain** – how it works, the members of the supply chain and their relationships to each other, and how this is defined by the INCO terms.



- **Transit Times** from printer, to delivery, to your door; why the times vary and what control you can have over it; the options available to you; the differences in cost and transit time for each method.
- **Definition of the terms** the terminology for each method including INCO terms and illustrations of pallets / containers / teu's / vessels.
- **Container** the pros and cons of full containers vs part-containers and consolidation.
- **Documentation** the documents required and who should supply them.
- **National Requirements** what you need to consider when shipping products around the world; the different rules / requirements depending on the departure and arrival points; VAT, Duty, taxes, anti-dumping duties, etc.
- Packaging the packaging requirements of your customers and the destination.
- **Insurance** what's covered by insurance and who is responsible.
- What can go wrong?
- **Economics** what impacts the costs in this market; what you get for your money; how long costs are valid for; what surcharges are and how they are calculated; is your cost per CBM, kilo or copy?
- **New innovations** super ships, The London Gateway Port, etc.
- **Communication** how to get the information you need; purchase orders, order monitoring, consolidation, web tracking, end-to-end visibility; EDI transfer of information.
- **Environmental Consideration** the environmental impact of each method and what you should consider when assessing them.
- **Pros and Cons** the pros and cons and limitations of each method.
- **Combined Methods** when it's appropriate to combine methods and the options available.
- **Books and Book Plus** what to consider when shipping books and books Plus.
- Importation into the UK/EU what to consider when importing into the UK, Customs, VAT, BTI codes, etc.
