

Under the **Presidency of Sierra Leone**, the Security Council held **two signature events**:

• A high-level open debate on **Maintenance of international peace and security** (12 August), focused on addressing the historical injustice and enhancing Africa's effective representation in the UN Security Council (S/2024/574). The President of Sierra Leone presided over the meeting. The Council heard briefings by the President of the General Assembly and the Secretary-General.

• An open debate on **Peacebuilding and sustaining peace** (21 and 22 August), focused on the New Agenda for Peace – addressing global, regional and national aspects of conflict prevention (S/2024/581). The Minister of Foreign Affairs and International Cooperation of Sierra Leone presided over the meeting.

Key Topics

The **Middle East** was the most frequently considered country- or region-specific item in open and closed discussions (14, 15, 19 and 28 August), followed by **the Middle East, including the Palestinian question** (13, 22 and 29 August) and **Sudan and South Sudan** (5, 6 and 14 August). **Somalia** (12 and 15 August) and **Ukraine** (28 and 30 August) were also discussed more than once.

Other country- or region-specific items included: Democratic Republic of the Congo, Libya and Non-proliferation/Democratic People's Republic of Korea. Under other matters (AOB), Council members discussed the 16th anniversary of the Russia-Georgia war, the situation of humanitarian personnel worldwide, Nord Stream and a joint letter from Mali, Niger and Burkina Faso addressed to the President of the Security Council (S/2024/623).

In addition to the signature events, the Council held a thematic meeting on **Women and peace and security** and considered the SecretaryGeneral's periodic report on countering threats from ISIL/Da'esh under the item Threats to international peace and security caused by terrorist acts.

Procedural notes

On 20 August, the Security Council Working Group on Peacekeeping Operations and the Ad Hoc Working Group on Conflict Prevention and Resolution in Africa held a joint meeting to draw lessons from recent transitions of UN peacekeeping operations on the African continent and to facilitate a joint discussion about the role the Security Council could play in setting the conditions for successful UN transitions and sustaining peace, including exploring the role of Troop-and-Police Contributors (T/PCCs).

On 21 August, Sierra Leone, Slovenia and Switzerland launched the Presidency Trio for Conflict Prevention committing to follow a proactive and comprehensive joint action during their respective Security Council presidencies in support of the UN Secretary-General's New Agenda for Peace.

Decisions and press statements

In August, the Council unanimously adopted four resolutions and issued two press statements.

On 6 August, the Council adopted resolution 2746 (2024), authorizing the **United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO)** to support the Southern African Development Community (SADC) Mission in the Democratic Republic of Congo (SAMIDRC).

On 12 August, acting under Chapter VII of the Charter, the Council adopted resolution 2747 (2024), extending by three days the authorization for African Union (AU) Member States to deploy uniformed personnel to the **AU Transition Mission in Somalia (ATMIS)**.

On 15 August, acting under Chapter VII of the Charter, the Council adopted resolution 2748 (2024), extending the authorization for AU Member States to deploy uniformed personnel to **ATMIS** until 31 December 2024 and requesting the Secretary-General, jointly with the AU Commission Chairperson, to report on the overall mission design for the proposed successor mission by 15 November 2024.

On 28 August, the Council adopted resolution 2749 (2024), demanding the full implementation of resolution 1701 (2006) and extending the mandate of the **United Nations Interim Force in Lebanon (UNIFIL)** until 31 August 2025.

The Council issued two **press statements**: one on **Libya** (SC/15804) and one on terrorist attacks in **Burkina** Faso (SC/15806).

Other activities

In August, Council members convened **one Arria-formula meeting** on the following topic: "**Crimes of the Ukrainian Armed Forces and the nationalist battalions**" (13 August), organized by the Russian Federation.

Additionally, at the invitation of Switzerland, members of the Council visited Geneva on 25 and 26 August to mark the **75th anniversary of the 1949 Geneva Conventions**. All Council members except the Russian Federation participated in the **informal visit**.
