

## **Privacy Policy**

Onlineforms.twas.org is a web platform to collect applications, nominations and registrations for the programmes and activities of The World Academy of Sciences (TWAS) and the Organization for Women in Science for the Developing World (OWSD).

Your privacy and the privacy of all users of onlineforms.twas.org are important to us. We take every precaution to protect the information you provide.

In connection to your use of this platform, TWAS and OWSD ask for and collect information including your name, email and postal addresses, education and professional appointments and other information needed to process and assess your applications. The data you provide will be processed for the purpose of selection or registration and in connection to any subsequent possibility of participation in an activity or programme of TWAS and OWSD, unless otherwise indicated.

TWAS and OWSD do not collect information for any other reason beyond those described above. Information you provide on this site will not be shared with any body outside TWAS and OWSD or the selection committees without your express permission and will not be used for any commercial purpose.
