The AGRI Committee clarified the scope of the INI report on 'the future of agriculture and what CAP after 2027'.

Taking into account these clarifications, the INTA Committee withdraws its previous request for an

opinion under rule 57, provided that the AGRI INI will not touch upon INTA competences on trade, including World Trade Organisation matters (Annex V).

BUDG decided not to draw up an opinion but considers that the AGRI report should not encompass considerations of future funding needs for the CAP and should steer clear of discussions that would directly impact on the position BUDG might take on the post-2027 budget (Annex VI).

ENVI requested authorisation to draw up an opinion to this report under Rule 57 (Annex VII).

AGRI Coordinators, during the meeting on 25 November 2024, decided to not oppose to this request.

ENVI requested authorisation to draw up an opinion to this report under Rule 57 (Annex VII).

### 9.3. ***Follow-up of the meeting between the Chair and EESC NAT Section President Peter Schmidt***

The Chair received an invitation to present AGRI priorities in a NAT Section meeting of the EESC in the 1st half of 2025.

### 9.4. ***Commissioner Hansen participation on mission to Japan 9-13 June - Call for stakeholders participation***

In Annex VIII, Coordinators may find the letter from Commissioner Hansen to Chair Vrecionová. Mr. Hansen will participate in a high-level mission to Japan from 8 to 13 June to meet political high level actors, in particular the Japanese Minister of Agriculture. Mr Hansen would like to include in the delegation companies from all EU Member States with the most significant potential for the EU's trade and cooperation with Japan.

Interested companies and organisations are invited to register their application by 9 February 2025. Commissioner Hansen would be grateful if you could disseminate this information to your stakeholders.

***Greens group is reluctant to invite MEPs to indicate companies to accompany Commissioner Hansen to the mission to Japan.***
