1. *CONT working methods concerning standing rapporteurs (postponed from last meeting)*

At their meeting of 5 November, Coordinators decided to appoint standing rapporteurs in the following six areas:

- The monitoring of the application of the Rule of Law conditionality Regulation (EPP)
- The anti-fraud architecture: OLAF and Europol/Eurojust (ECR)
- The anti-fraud architecture: EPPO (Renew)
- The implementation of the RRF (S&D)
- The monitoring of the financial assistance to Ukraine and relations with the budget committee of the Verkhovna Rada (Greens)
- Financial assistance to The Western Balkan (The Left)

Decision:

Coordinators representing a clear majority in the committee, approved the proposal for working methods concerning standing rapporteurs with an amendment from Renew. The working methods are:

- Standing rapporteurships are attributed at no cost in points for half of the legislative term;
- All files under the corresponding topic shall be attributed to the standing rapporteurs at no cost in points (legislative proposals and opinions to legislative proposals);
- An INI under the scope of a standing rapporteurship may be attributed without any points to the political group that submitted the proposal, unless the standing rapporteur objects, in which case she/he will be attributed the report without any points;
- Standing rapporteurs may be delegated responsibilities related to the file under their responsibility, e.g. the Chair may delegate to a standing rapporteur the responsibility to issue an opinion in the form of a letter;

2. *Own-initiative reports*

2.1. *New own-initiative report (INI)*

On 4 December 2024 Coordinators decided to request the authorisation to draw up five

own-initiative reports (INI). Afterwards Coordinators decided in a written procedure to change the nature of the INI-report on the Future of the Rule of Law Conditionality Regime into a joint BUDG-CONT implementation report. Since implementation reports do not count against the quota for INI reports, this change freed up a slot for an additional INI report for the first half of the legislature.

Decision:

Coordinators representing a clear majority in the committee selected the following report from the reserve list: “20 years of Progress: Evaluating the Successes and Lessons in implementing the EU Budget from EU Enlargement in 2004”.

2.2. Attribution of the requested INI reports

Following the Coordinators meeting of 4 December 2024, the Chair requested authorisation of the following five INI reports:

- 1) Implementation report jointly with BUDG under Rule 59 RoP: Implementation of the Rule of Law Conditionality Regime
- 2) Control, transparency and traceability of performance based instruments
- 3) Budget 2024: Assessing the implementation of the gender mainstreaming methodology in the EU Budget
- 4) Combating VAT fraud - the effectiveness of cross-border cooperation between Member State tax authorities, particularly in the digital domain.
- 5) Which performance indicators relevant for audit and budgetary control should be implemented in the context of financing measures taken to support the implementation of a future European competitiveness?

LIBE asks to be associated under Rule 59 to the implementation report under 1).

FISC/ECON have contested the INI report under 4) on Combating VAT fraud.

Decision:

Coordinators decided the following distribution of reports:

- 1) Given to EPP without points because of the standing rapporteurship;
- 2) Given to the EPP for 1,5 points;
- 3) Given to S&D for 1,5 points;
- 4) Awaits clearance of competence;
- 5) Given to Renew for 1,5 points;
- 6) The additional report selected under agenda item 2.1 was given to the EPP for 2,5 points.

3. Selection of ECA Special Reports for presentation in CONT up to quarter 3, 2025

Based on the latest version of ECA’s indicative timetable of 21 January 2025, the Secretariat proposes to present the following SRs and reviews in CONT (screened including quarter 3, 2025).

For the sake of having a complete overview also of the already selected special reports and reviews mentioned in the list, they are included in the below list (the title and expected timing of publication might have slightly changed):

Decision:

Coordinators approved the above list of selected reports and reviews to be presented in CONT.

4. *Proposals for missions in 2025*

According to the rules, missions should be organised in the turquoise weeks (weeks for external activities). It requires a special authorisation to organise missions outside these weeks.

Decision:

Coordinators decided to ask authorisation for the following missions in 2025:

- Week 22, Slovakia: The mission should be arranged Monday-Wednesday, 26-28 May to Bratislava;
- Week 38, Albania and Montenegro: The mission should be arranged Monday to Wednesday, 15-17 September to Tirana and Podgorica;
- Week 44, The Hague (European Cybercrime Centre (JRC)): The mission should be arranged Monday to Tuesday, 27-28 October.

5. *Input to the 2026+ ECA work programme*

The CCC Chair invited committees to provide their audit suggestions for the 2026+ ECA Work Programme to the CCC Secretariat by Wednesday 21 February 2025. An exchange of views with ECA President Tony Murphy is foreseen for the CCC meeting of 11 February 2025.

The Secretariat received 23 proposals for ECA audits from the groups.

Decision:

Coordinators representing a clear majority in the committee selected the following audit suggestions for the 2026+ ECA Work Programme to be sent to the CCC Secretariat on behalf of the CONT Committee:

Merging the following proposals:

- No 5 (EPP), no 7 (S&D) and no 17 (Renew)
- No 6 (S&D) and no 20 (Renew)
- No 8 (Pfe) and no 21 (Greens)
- No 12 (Pfe) and no 22 (Greens)

Not to select the following proposals: 9, 10, 11, 14, 15, 16, 23.

A clean list with suggestions from CONT, including a suggested text for the merged proposals, will be sent to Coordinators for final approval.

6. *Letter to Commissioner Dombrovskis concerning the 100 largest recipients of RRF funding per country*

The Coordinator from the Greens proposed to the Chair to write a letter to Commissioner Dombrovskis concerning the 100 largest recipients of RRF funding per country.

The CONT Committee has for many years been asking for information concerning the biggest final beneficiaries from traditional EU policies like agriculture and structural funds and during the last couple of years also the RRF. For the RRF, the Commission only provided a list of recipients consisting to a large extent of public entities and ministries who are not the final recipients since these entities will then spend the money and thereby pay contractors.

Decision:

Coordinators approved the draft letter to Commissioner Dombrovskis.

7. *Opinion concerning the 2026 budget guidelines in the form of a letter from the Chair/Commission 2023 rapporteur*

At the meeting on 4 December 2024, Coordinators decided that CONT should provide an opinion to the 2026 budget guidelines in the form of a letter and agreed to continue the standing practice of appointing the Commission discharge 2023 rapporteur (the Chair) as Budget 2026 Rapporteur.

Decision:

Comments to the letter in written should be sent to the Secretariat at the latest on Friday 31 January.

The final letter will be voted in the Committee at the meeting on 17-18 February as a single vote.

8. *Possible invitation to the President of the Hungarian Integrity Authority*

In the light of recent allegations of corruption against the President of the Hungarian Integrity Authority and the obstacles he already denounced earlier, an exchange of views with the President of the Integrity Authority could be envisaged in connection with the preparation of the joint implementation report of BUDG and CONT on the Rule of Law Conditionality Regulation.

Decision:

Coordinators representing a clear majority in the committee decided:

- To invite the President of the Hungarian Integrity Authority to a meeting in the CONT Committee;
- That the Chair together with the President of the Hungarian Integrity Authority may decide if the meeting should be In Camera or public;

- The Secretariat will examine the possibilities for having the President of Hungarian Integrity Authority attending the meeting in person or whether his participation will have to be remote.

9. *EP Discharge - Budget item 400 (2024 first semester)*

In the framework of the EP discharge, the Secretary-General forwarded the financial reports of six of the political groups i.e. the audit reports and the financial reports for the first semester 2024 to CONT and asked the Committee to keep him informed about the steps of the procedure that it will follow before the reports can be submitted for adoption by the Bureau

Decision:

Coordinators approved the draft reply from the Chair to the Secretary-General.

10. *Petition(s) received for information*

The Chair of the Committee on Petitions, has sent the following petitions to the CONT

committee for information:

- **Petition No 0947/2024** by T.K. (Polish) on the environmental consequences stemming from the planned construction of the N-S Route in Ruda Śląska, Poland

11. *BUDG-ECON working group*

On 27 November 2024, the Conference of Presidents endorsed the renewal of the mandate of the joint BUDG-ECON working group on the scrutiny of the RRF (RRF WG) for the 10th term. The CoP endorsed all aspects of the draft mandate submitted by the BUDG-ECON Chairs on behalf of the Coordinators, with one important change in relation to missions. Accordingly, the BUDG-ECON working group will be composed of 27 Members designated by the political groups on the basis of d'Hondt, which translates to the following breakdown: 8 EPP, 5 S&D, 3 P/E, 3 ECR, 3 Renew, 2 Greens/EFA, 2 The Left, 1 ESN. The RRF WG Members should be primarily drawn from BUDG and ECON but it should be ensured that each of the associated committees (EMPL, ENVI, ITRE, TRAN) and CONT (responsible for the RRF discharge) are also represented by one Member, to be counted within the quota. The CONT Member to the BUDG-ECON working group is Ms Carla TAVARES. Concerning RRF WG missions, the CoP departed from the BUDG-ECON proposal to count these missions outside the quota. As a rule, RRF WG missions will be treated in the same way as ordinary committee missions, that is inside the quota for missions. However, the CoP decision allows for the possibility of mission requests above the quota of both BUDG and ECON. The CoP will decide on the authorisation of such requests on a case-by-case basis.

12. *Outcome of written procedures*

In response to the written procedure of 11 December 2024, a large majority of Coordinators agreed with the Secretariat's proposal to request for the INI on "***Future of the Rule of Law Conditionality Regime***" an implementation report rather than a non-legislative initiative report. This implementation report will be drawn-up jointly with BUDG.
