3.1.1. Proposal for a Regulation on a public interface connected to the Internal Market Information System for the declaration of posting of workers and amending Regulation (EU) No 1024/2012 (e-declaration of posting of workers) - COM(2024)0531 - SWD(2024)0258 - 2024/0301 (COD)

- *Coordinators took note of the state of play of the file and decided to postpone the allocation to a political group to the next meeting.*

3.2. Opinions

3.2.1. The role of cohesion policy in supporting the just transition (2024/2121(INI))

- *Coordinators allocated the opinion to EPP.*

3.2.2. The role of cohesion policy investment in resolving the current housing crisis (2024/2120(INI))

- *Coordinators allocated the opinion to the Left.*

3.3. Other non-legislative documents referred to EMPL as lead committee

3.3.1. Proposal for a **joint employment report** from the Commission and the Council - **COM(2024)0701**

- *Coordinators took note of the proposal for a joint employment report, agreed not to take any further action at this stage, but to take it into account in future committee activities.*

4. Future of economic governance

- *Coordinators endorsed the actions proposed for strengthening the existing mechanisms under the employment and social strand of economic governance and the EMPL role in the surveillance of employment and social policies.*
- *Coordinators mandated the Chair to write to ECON, requesting them to integrate EMPL Members into their existing working group on economic governance. If the request is denied, Coordinators agreed to discuss whether to establish an EMPL working group on the social dimension of economic governance.*

5. EMPL working and monitoring groups

- *Coordinators decided to:*
 - *Re-establish the European Child Guarantee Working Group in the 10th legislative term, the focus of which should continue to be on the implementation of the European Child Guarantee, and to propose Members (1 per group) to the Working Group by 18 February 2025. The chairmanship of the WG will be decided once established.*
 - *Establish Monitoring Groups on the Platform Work Directive and the Minimum Wages Directive, and to propose Members (1 per group for each monitoring group) to the Monitoring Groups by 18 February 2025. The chairmanships of the Monitoring Groups will be decided once established.*

6. EMPL input for ECA work programme 2026+

- *Coordinators agreed that the following topics be submitted as EMPL input for ECA's work programme 2026+:*
 - *Upskilling and reskilling investment,*
 - *Special report on the European Globalisation Adjustment Fund for Displaced Workers (EGF),*
 - *Youth Guarantee.*

7. EMPL working methods

- *Coordinators decided to postpone the adoption of the working methods to the next meeting, after an additional meeting at technical level.*

8. Current situation of the Parliament's childcare facilities and the overall situation of the staff

- *Coordinators decided to hear representatives of the trade unions and the EP administration on the situation of childcare facilities at their next meeting.*

9. ECJ Case C-19/23 - minimum wages: opinion of Advocate General

- *Coordinators took note of the opinion of Advocate General, heard the EP Legal Service and decided to come back to this issue once the Court of Justice has taken the final decision to analyse possible consequences and follow-ups.*

10. Joint EMPL/REGI public hearing on housing

- *Coordinators endorsed the proposed format of the public hearing, and agreed to submit to the secretariat proposals for speakers to be invited (max 2 per group) for the second session entitled 'Improving access to adequate, decent and affordable housing for all' by 6 February 2025.*

11. Update on EMPL own-initiative reports (INI) requests

11.1. Strengthening the social impact of public procurement in the EU

- *Coordinators agreed to adapt the title of the INI report in order to find agreement with IMCO.*

11.2. EU strategy for the rights of persons with disabilities post-2024

- *Coordinators agreed to LIBE and FEMM providing opinions to this INI, in addition to CULT, PETI and SANT.*

12. Ad hoc visit to the German Artificial Intelligence Centre (DFKI), Kaiserslautern

- *Coordinators agreed to continue the preparation of the ad hoc visit to DFKI to take place on 10 March 2025, and to send an informal delegation composed of maximum 1 MEP per group.*
