## 1.1 REFERRALS/ATTRIBUTIONS

### 1.1.1 Appointment of the ITRE Rapporteur for opinion for the budgetary procedure

The opinions for the next two budget years (2026/2027) were allocated to the S&D for 1 point.

### 1.1.2 Discharge Procedure 2023

No opinion. The Secretariat will monitor the discharge procedure in CONT with regard to issues that are relevant for ITRE and keep the Coordinators informed as appropriate.

### 1.1.3 Requests for own-initiative reports in the Conference of Committee Chairs

## 1.2 Own-initiative reports

The precise titles and scopes of the INIs will be developed by the political groups, in cooperation with the Secretariat.

The Committee will also draw up a question for oral answer, accompanied by a motion for resolution, on “Energy-intensive industries”.

### **1.3 Gender mainstreaming - nomination of ITRE Standing Rapporteur**

Ms Elena Sancho Murillo (S&D) was appointed as ITRE Standing Rapporteur for gender mainstreaming. Ms Alexandra Geese (Greens/EFA) was appointed as substitute.

### **1.4 Petitions Network - nomination of ITRE representative**

Mr Daniel Attard (S&D) was appointed as ITRE representative to the Petitions Network. Mr Michalis Hadjipantela (EPP) was appointed as substitute.

### **1.5 Network on the implementation of the United Nations Convention on the rights of Persons with Disabilities (UNCRPD)**

ITRE will request to join the Network. Political groups were invited to submit, by 4 November 2024, their nominations for an ITRE representative to the Network.

### **1.6 Working Group on the implementation of the DSA & Working Group on the implementation of the DMA - Nomination of ITRE representatives**

Political groups were invited to submit, by 4 November 2024, their nominations for the ITRE representatives to the two Working Groups.
