Coordinators did not agree with the Greens/EFA proposal to have an external speaker for Session 2 of Panel 2 instead of the Schengen Coordinator in the European Commission as proposed by the LIBE Committee. Coordinators did not agree with the Greens/EFA proposal to move the European Commission's speaker to Panel 1 to cover session 1 on the "Historical overview".

Coordinators endorsed the draft program and appointed the following experts: Professor Kapka Georgieva-Atanasova and Mr Sergio Carrera.

11. Follow-up on Petition No 0949/2024 by Kristiyan Pishtikov (Bulgarian) on allegedly discriminatory clauses in the newly adopted education code in Bulgaria

Coordinators decided to close Petition No 0949/2024 based on the information included in the Chair's compromise.

12. ECA Work Programme 2026

Coordinators were invited to submit proposals for topics to the ECA work programme 2026 by email to PETI secretariat by 5 February 2025 and to use the Template for Committee contributions to the ECA Work Programme. The consolidated version of the PETI proposals will be endorsed by Coordinators at their meeting in February 2025.

Coordinators appointed MEP Bosanac from the Greens/EFA group as PETI full Member in JURI Network on Monitoring the Application of Union Law.

Coordinators also agreed on the following topic of the Disability Workshop: 'The Concluding observations by the Committee of the UN Convention on the Rights of Persons with Disabilities', expected for summer 2025 with a briefing giving an overview of the review process and highlighting some of the main concluding observations that are most relevant from the perspective of petitions received.
